We have been involved with the University of Bristol's "Getting Things Changed" research for over a year now, and we presented at the October conference.




IMAGE 1: how our work supported the work of Reasonable Adjustments in Hospitals and how we continue to

Dr Stuart Read also attended our Healthwatch Conference and presented the interim findings and the purpose of the research to various healthcare professionals. As a result, the team have been to the University of Bristol NHS Trust to speak to the Patient Experience Team and how more knowledge around Reasonable Adjustments should be addressed and anticipated

across the trust. One commentator at our March conference expressed their main reason for attending was to listen to the presentation on Reasonable Adjustments.

What did we hear?

We attended the workshop on Reasonable Adjustments as part of the conference and listened to various experiences of disabled people, both at local and regional hospitals. We were asked to participate on a case study to ensure the right reasonable adjustments were made, engaging in reflective practise on different professional and patient perspectives.

The Overall Findings:

- Some hospital staff are doing excellent work in providing reasonably adjusted care - several examples were listed in our first report.
- The provision of Reasonable Adjustments requires individual members of staff to see the "value" of reasonable adjustments, and to go "above and beyond" what is typically practiced does not appear to be routine within hospitals.
- Disabled people reported "mixed" experiences during their hospital journey.
